CONSENT TO USE THE IMAGE

I, the undersigned, consent and authorise, free of charge, **Oknoplast sp. z o.o.** with its registered office in Ochmanów (hereinafter referred to as “Oknoplast”) and any entities acting on its behalf or in cooperation therewith (e.g. museums and art galleries, including MOCAK The Museum of Contemporary Art in Krakow, entities belonging to the same capital group, marketing agencies) to:

1) to use my image (hereinafter: “Image”) fixed in the design of the work, hereinafter: the “work”, submitted to the “Oknoplast for Art” Contest, hereinafter referred to as the “Contest”, and created by _____

_____ for the purpose of submitting the work to participate in the Contest, assessing it and announcing its results;

2) in the event that the work is awarded in the Contest, I hereby grant my consent to the use of my Image by means of recording, reproducing and disseminating the whole Image or any part of the Image and retain it in the award-winning work for the purposes related to Oknoplast’s advertising, commercial, recruitment and information activities, in digital and printed form, including in particular by use thereof:

- in Oknoplast materials addressed to employees and associates, job candidates (e.g. presentations and internal videos)
- on social media, i.e. LinkedIn, Facebook, Twitter, Instagram, Pinterest, YouTube, Tiktok, blogs and websites, including those of Oknoplast or Oknoplast’s business partners and associates;
- for advertising purposes, e.g. on billboards, leaflets, citylights, TV and the Internet,
- in promotional materials and public relations messages,
- in order to exhibit the Contest-winner’s work on which the Image was recorded as part of Oknoplast collection, during exhibitions and events, e.g. trade fairs.

I also agree that the Image may be modified, accompanied by additional photographs, graphic elements, captions, change of colours and presentation techniques, any digital processing, use in collages, collections of materials, etc. – at Oknoplast’s sole discretion – and that the Image may be distributed in whole or in part.

This consent to the use of the Image is not limited in time or territory, covers the territory of Poland and any other countries.

Oknoplast may allow for the use of the Image by entities affiliated with Oknoplast, e.g. WnD sp. z o.o. and entities cooperating with Oknoplast – without the need to obtain additional consent.

The Image shall be used with due diligence and with respect for moral rights and generally accepted social norms.

The consent is granted free of charge. I undertake not to raise any claims against Oknoplast or those who use the Image upon Oknoplast’s consent, which could result from the recording or use of the Image – in particular no financial claims.

I undertake to Oknoplast that within a period of 3 years I shall not revoke the above consent to use the Image, nor will I perform any factual or legal acts that may prevent or hinder the use of the Image by Oknoplast.

Information on the processing of personal data

- 3) Your personal data will be processed in order to:
 - a) for the use of the Image – the legal basis is the legitimate interest of the Controller (Article 6(1)(f) of the General Data Protection Regulation 2016/679 – hereinafter referred to as the “**GDPR**”), for the purpose of its assessment once the work will have been submitted for the Contest and, if rewarded, for the use of the Image in connection with your consent;
 - b) allow for possible establishment or assertion of claims or defending against them – where the legal basis for processing is the legitimate interest of Oknoplast Sp. z o.o. (Article 6(1)(f) of the GDPR). The legitimate interest is to allow Oknoplast Sp. z o.o. to assert or defend against claims.

- 4) Your personal data will be transferred to entities providing Oknoplast Sp. z o.o. with services necessary for the performance of the agreement we concluded with you. The Image shall be used only in connection with the dissemination of work on which it will have been created.
- 5) Your personal data will be processed for the period determined in your consent to use your Image. If the processing of personal data is necessary for the exercise or defence of possible claims by Oknoplast Sp. z o.o., the processing period may from time to time be extended by the statute of limitations for claims.
- 6) Personal data will not be transferred outside the European Economic Area unless it is necessary for the organisation of the exhibition or dissemination of work on which it will have been created. - 7) You have: the right of access to your data, the right to request rectification and erasure of your data and to restriction of its processing, the right to data portability and the right to object to data processing on grounds of the legitimate interest.
- 8) You also have the right to lodge a complaint with a supervisory authority responsible for personal data protection in your country of residence, if you believe that the processing of your data is contrary to the provisions of the GDPR. - 9) The provision of data is required by Oknoplast in order to give consent to the use of the image. Refusal to provide data would mean that you do not consent to the use of your Image and that the project containing the Image will not be admitted to the Contest.
